My report is on the website.

We have 39 members, of these 35 are BCA affiliated clubs, 3 BCA associated clubs and 1 BCA non-affiliated club.

I have almost completed the handover from Dave Cooke and the Bank mandates are nearing completion. The approved expenditure list has been updated from previous minutes and will be sent out to the officers.

We received an advance of £5000 from the BCA for a claim against spending which has occurred this year, which we have received invoices for. We are awaiting the response from the BCA C&A committee to see what has been approved.

In my report I mentioned the Hinkley Point C community fund grants. I have spoken to the person from Somerset council who administers these grants on behalf of Hinkley Point.
